V. Family Leadership Council report

The FLC met on June 9, 2022

The June FLC Agenda included:

- How to support parents/caretakers to create letters of concern in a package to state legislature
- Whether or not the FLC has lobbied before and if not how to start that up
- Regional Stewardship Council looking for help to represent underrepresented racial and ethnic groups in the area
- Started planning FLC end of year celebration

VI. Family Preservation Funds Background:

- Title IV B2 Waiver Funds that are allocated in the Hub contract traditionally given under the umbrella of family support services, which usually are used to support family support resource centers, which is now broken up into two different streams.
- One steam is for \$75,000 and is allocated as Family Preservation; Family preservation, respite, reunification, and preventative services for families of kids aged 0-6, who are currently facing separation or have been separated.
- The discussion became about how to allocate these funds to places that are already providing these services and three agencies were located:
 - Family Relief Nursery
 - Relief Nursery
 - Pearl Buck
- Discussion has been made about what the usage of funds and the impact would be. All agencies would use funds to support therapeutic classrooms and other intensive family support services.
- Claire Hambly proposes to split the funds (\$75,000) into three equal awards of about \$25,000 each for each of these three agencies.
- There is no indication if the award will continue in the next biennium, so this vote would just be for the remainder of this cycle.

Group Discussion

- There was no discussion about how many children would this money support specifically because it would be a hard number to quantify for what the ask is
- The thought behind the decision was for simplicity reasons due to the nature of the money and an uncertainty of if it will be available again.
- The deciding committee thought that an RFA process or creation of a scale for the funds were unnecessary.
- This money would fund Relief Nurseries' core program, which is considered therapeutic and consists of outreach, home visits, parenting education and therapeutic relief programs
- Leslie Finlay describes that their program is wraparound so the money that would be given would be able to fully help one and a half children if children and parents utilize all services available
- Noreen clarifies that United Way continues to fund annual community support grants including Pearl Buck and Relief Nurseries, and that United Way will be distributing coalition grants soon with Family relief nursery and Cottage Grove in Southern Lane County
- These three agencies have capacity needs and this would aid in that

VII. Preschool Promise Selection Criteria Change Background

- Preschool Promise is a free state-funded high quality Preschool program for children who are 3 or 4 years old in Oregon. There is an income requirement that the family is below 200% or below the federal poverty level. There is currently 190 slots in the county, with a hope to increase the number of slots by 260
- As part of the process to place, families within a preschool there are selection criteria that are used. Selection criteria are based on a list of priority populations stated by the state as well as populations identified by each hub.
- The Early Learning Division told the regional stewardship committee, to adjust the selection criteria as needed through the use of data and implement their findings in the following program vear.
- At the time the Early Learning Division reached out to the Regional Stewardship Committee, they had already convened twice and knew that with the deadlines in place there may not be enough time to create new selection criteria. They instead used the already in place selection criteria and sent it to an attorney, under the advisement of the ELD.
- Regional Stewardship Committee will reconvene this fall to create better-established selection criteria for the following Preschool Promise program year.

Current Order of Selection includes:

- 1. Transfer Students
- 2. Conversion Students
- 3. Siblings of Children already enrolled in PSP
- 4. For school-based PSP programs, children living within a catchment area
- 5. Children who are a member of one or more of our priority populations (Children of Color, Emerging language learners, special needs, children in rural or geographically isolated areas, children living in socially complex families (children of teen parents/incarcerated parents/parents who have cognitive limitations, student parents)
- 6. All other children
- Because PSP is federally funded, it is subject to Title VI which states that PSP is prohibited to discriminate based on race
- PSP cannot factor race to prioritize families so Order of Selection 5 cannot be used
- Recommendations/options given from the attorney include
 - Going forward with the use of race and understanding the risk that goes along with it
 - o Remove "Children of color" from the priority population
- Other hubs create lotteries and Order of Selections differently so have not seen this issue
- Data was used to find other trends to get BIPOC children all fall under

 One trend was a that if a parent/guardian speaks a language other than English this was about 80 out of 130 BIPOC children

Group Discussion

- Question presented for the group was: Has anyone else come across this or any thoughts on how PSP could change the selection process to better serve underrepresented or historically marginalized communities of color
- Potential ways to reach these communities include outreach and recruitment and relationship building to help more marginalized community members sign up for PSP since they are no longer prioritized
- Brian Johnson discusses the potential use of zip codes or census blocks for those with more BIPOC communities or more impoverish communities
- Judy Newman discusses potentially adding more data in the application process to see if there
 are additional identifying factors or using a focus group of people that get accepted in the
 upcoming program year
- Noreen discusses potential works in policy and advocacy to help create change for the 2023-2024 fiscal year
- Other hubs have talked about potentially asking for additional funding to help to support more children
- Annie Soto talks about a better representation within the Preschools to help make sure that children can look at the staff and see themselves, or their community
- Other hubs have culturally specific providers, so their selection process is different depending on the providers
- Kraig Sproles agrees that the most important thing is to create an open and inclusive area for kids and to look at faith based organizations or other organizations to be the target for outreach.
- Michelle Hjelm says "We also will continue to place large amounts of energy on prioritizing outreach to communities of color in terms of seeking feedback about enrollment process and marketing materials so that we can make sure to be breaking down barriers to increase future access"
- The change is to include the parent's language as other than English, rather than just the children who speak a different language.
- Christie states that "I imagine one challenge is there's only so much in-person outreach staff can do-- glad you're looking at the materials themselves, and the process"
- Adrianna Medina Garcia suggests the prioritization of families involved in supporting organizations for BIPOC communities such as NAACP
