

Vaccines for Children Clinics in Lane County

The Vaccines for Children Program supplies vaccines at no-cost or low-cost for children ages 18 and under who are on Medicaid/Oregon Health Plan, underinsured with a high deductible, or are American Indian/Alaskan Native. Children whose health insurance policies do not cover some or all vaccines, or only cover vaccines until a child reaches a certain age (considered "underinsured"), may receive no cost immunizations at public sites such as the Lane County Health Department clinic and Community Health Centers of Lane County clinics.
